6	Indoor sports facility was not shown in the videography. The school is required to provide indoor sports facility and submit the compliance within 3 months on SARAS portal.
7	There is a ramp at the entrance of the building but there is no ramp/lift to access upper floor. The school shall construct the ramp or install a lift for CWSN students to access upper floor as per RPwD Act 2016 and submit the compliance within 3 months on SARAS portal.
8	As per IC report, (a) Lesson plans and teaching aids needs to be at par with CBSE standards and submit the compliance within 3 months on SARAS portal.
