CONDITIONS:

- The school and the standards conducted by the said school has been duly recognized and has been authorized to render and conduct (Primary Education/Secondary Education) 1 to 5th (1 to 5, from 1 to 8, 6 to 8,9 and 10 and also 1 to 10). The school is not authorized to conduct and carry on classes at higher levels or options from that mentioned so.
- The school shall function in accordance with the rules and regulations as specified in the Karnataka Education Regulations and Laws-1983 and also Childrens' Education Rights-2009.
- 3. A mandatory 25% of the total seats allotted by the school has to be sanctioned and allotted to the students belonging to the weaker sections of the society, and also the allotment of the seats belonging to the RTE category is allotted and declared so. Such a facility extends to schools located close by to the residences of the parents'/guardians' of the students. Following so the mentioned condition applies to government schools and government aided schools. If otherwise, private schools need to facilitate the admission of such students providing them till the completion of the primary level without any level of discrimination.
- 4. As specified for those sect of students falling under the RTE category the government shall release the prescribed fees and no fees shall either be imposed upon or collected from such students by the private schools.
- 5. The school or its Managing Committee so recognized shall neither collect any capitation fee or any other donation from the parents/guardians of the students.
- 6. The directions as issued by the Department of Education in ED:31:PGC:2019 fixes the specified tuition fees that shall be charged and collected from the guardian/parent of the students. The details of which shall be informed in the website of the Department of Education and such other directions issued to the schools.
- 7. The school and its Managing Committee shall abide by that date as declared or announced by the Department within which the admission needs to be made.
 - The school and its Managing Committee shall not deny admissions to any student on the basis of the following reasons:

a. \ Sufficient evidence/proof of age.

ball On the basis of caste, religion and place of birth.

Requisition of admissions after the specified last date of admission.

The recognized schools shall follow all the prescribed safety measures by the Department in following the rules and regulations of the RTE and the Karnataka Education Board (Has to compulsorily obtain a certificate from the Fire Brigade Department and also the Certificate

of Approval from the Building Conservation Department, the K.S.C.P C.R and the N.C.P C.R with regard to the learning, study and indoctrination.

- 10. The school and its Managing Committee shall have to follow the below mentioned as not to
 - a. Detain or fall any student till the completion of its primary or middle school education or restigate him/her.
 - b. No student should be subject to physical and mental torture or punishment.
 - c. No student need to pass any other Board Examination till the completion of its primary
 - d. At the completion of its primary education the students shall be given certificates in accordance with the regulation 12 of the RTE and the Karnataka Education Board.
 - e. The rules of the RTE and the Karnataka Education Board specifies the admission of the specially children and also those students who need special attention.
 - f. The RTE regulations and the rules of the Karnataka Education Board fixes the minimum qualification of every teacher to be appointed.
 - g. The salaries, allowances and other service incentives shall be as such fixed by the Government. Through the notifications of the Government the remittance of the PE and the ESI and such other salaries shall be made to the accounts in those specified banks.
 - h. The Teachers rule Section-24(1), the RTE and Rule-17 of the Karnataka Education Rules and Regulations specifically forbids teachers from Involving and taking up private tuitions.
- 11. The teaching materials, aids, methods and the texts of the schools shall be as those fixed Integrated Educational Authority.
- 12. Section-19 of the Karnataka Education Rules declares that the admission of students to the school shall have to be according to the facilities as made available to them in the schools.
- 13. The schools shall have to manage all the rules, regulations and other standards as specified in Section-19 and shall also the personnels to the department shall be appointed in accordance with the rules specified in the Karnataka Education Department.
- 14. No unofficial departments or classes shall be established, held or organized either within or outside the premises of the recognized school.
- 15. The basic essential facilities or amenities of the school or the premises of the school itself shall not be utilized or engaged for any political or commercial purpose.
- The school shall not be utilized for the benefit or profit of any organization or association.
- 17. The accounts of the school shall have to be duly checked and certified by a registered auditor or a chartered accountant and the same shall have to filed by the end of June with the Sub-Directorate or the Education Officer of that area.
- 18. The schools shall follow that rules regarding the language structures in accordance with the Kannada-Basha-Neeti-2014.
- 19. The schools and its managing authorities shall follow all the rules and norms as formulated by the rules of the RTE and the Karnataka Education Board in running the schools.
- 20. The schools and its Managing Committee shall have to mandatorily follow all the laws, rules regulations and directions as formulated by the Government and the Department of Education.
- 21. All the matters of the schools shall have to be reported and updated with the S.A.T.S unfailingly by the end of March.
